**SUBJECT: VOLKSWAGEN/AUDI DIESEL EMISSIONS SETTLEMENT PROGRAM
IMPORTANT DEADLINE – SEPTEMBER 16, 2016**

The following information has been provided by Abbott Nicholson:

The Federal Trade Commission and Volkswagen Group of America, and other interested parties, have reached a proposed settlement which is currently before the Court. Certain diesel VW and Audi vehicles that were purchased and sold during the following times are eligible for benefits under the proposed settlement for “Eligible Sellers.”

Eligible Sellers are those who:

- (1) Purchased or acquired an eligible vehicle on or before September 18, 2015; and
- (2) Sold or transferred ownership of the vehicle after September 18, 2015 but before June 28, 2016.

The proposed settlement states that **Eligible Sellers must identify themselves by September 16, 2016, to qualify for benefits**. Generally, Eligible Sellers include non-Volkswagen dealers (and non-Audi) dealers who held title to an eligible vehicle or held a bill of sale for an eligible vehicle. An Eligible Seller must identify itself by registering online at www.vwcourtsettlement.com or by submitting the attached identification form by mail or fax to receive any benefits. You can also visit the website to determine if certain vehicles are eligible for benefits under the proposed settlement.

Other eligible individuals, including owners, lessees, and certain former lessees have until September 1, 2018 to submit claims.

To qualify for an Eligible Seller Restitution Payment under this Class Action Settlement, you must identify yourself no later than September 16, 2016 by registering through the Online Claims Portal at www.VWCourtSettlement.com (**preferred**) or by filling out and returning this Eligible Seller Identification Form by mail (send to: VW Court Settlement, P.O. Box 214500, Auburn Hills, MI, 48326) or by fax (fax to: 1-248-754-6602). Paper Eligible Seller Identification Forms *must be received no later than September 16, 2016*. The purpose of this Eligible Seller Identification Form is to identify potential Eligible Sellers, and submission does not guarantee eligibility.

**Please visit www.VWCourtSettlement.com or review the enclosed Notice for eligibility requirements and applicable exclusions. Documentation of prior ownership and submission of a separate Claim Form will be required. If you qualify as an Eligible Seller, you will be entitled to at least \$2,550.*
